

## SECTION D – HONEY AND WAX

Entry Time – Tuesday, August 24th, 2010, from 1PM to 8PM, and Wednesday, August 25th, 2010, from 9AM to 8PM.

### Special Rules

1. All honey and wax must be the property of the exhibitor and must have been produced by exhibitor within a 15-month period prior to entry.
2. All honey exhibited must have been gathered and ripened in a natural way by honeybees.
3. Exhibitor's name or label will not be allowed on any entry. Small labels with exhibitor number and class number will be secured to the bottoms of jars or sections to avoid errors when exhibits are dismantled.
4. Judges may remove from public view any entry or part thereof which, in their opinion, discredits the exhibit.
5. The Superintendent of the Honey and Wax Section will determine, at the time of entry, the color of all extracted honey by the use of an official honey grader.
6. All extracted honey shall receive equal points on color within class, with the exception of "Extra White to Water White", which shall be graded according to color within class.

### Class Rules

1. Honey displays may include pictures and charts but not beekeepers' equipment, tools, observation hives, bakery products, canned goods or honey in tins. Minimum width of display is 3'. Maximum width of display is 5'.
2. All extracted honey entries must be exhibited in 1 lb. glass or clear plastic jars.
3. All chunk and finely granulated honey entries may be exhibited in glass or clear plastic jars of 1 lb. or more capacity.
4. All section comb honey entries must be wrapped in clear cellophane or be placed in window cartons.
5. Gift packs, Classes D24 and D25, **must include one or more products of the hive** and may include items to enhance appeal or promote the use of hive products. Personal gift packs should be suitable for personal gift use regardless of commercial application, and should be in a box, basket or other suitable container.
6. Any exhibitor who wishes information as to how his exhibit was placed by the judges can receive this information by consulting with the Superintendent of the Honey and Wax Section.
7. Exhibitors are limited to 1 entry per class.

**Educational Exhibit**

Object: To depict the importance of honey bees to mankind, i.e., economic goods - honey, beeswax, pollen, propolis, bee venom, byproducts, etc.; economic service - pollination; interesting and cultural recreation. Display should be 3-dimensional. Printed material should be readable from 4' away. Display to be at least 3' long x 3' wide to a maximum of 5' long x 3' wide.

**Maryland Beekeeping Organization Display**

Display may include honey in glass containers, (with or without labels), beeswax, other bee products, beekeepers equipment, or educational material approved by the Farm and Garden Department. Two of the ten Maryland Bee Associations will be invited to exhibit on a rotating basis approximately every 5 years.
