The fitting and preparation of all animals for exhibit is the responsibility of the Exhibitor. Exhibitors may receive guidance only from immediate family members, Maryland 4-H/FFA Members and appointed UME Volunteers/FFA Advisors.

### Division Rules & Regulations:

1. Exhibitors and their exhibits must comply with the "General State Fair Rules & Regulations", "General 4-H and FFA Rules & Regulations", "Animal Rules & Regulations", the "Maryland 4-H Code of Animal Science Ethics", the "Health Regulations for Livestock Exhibited in Maryland", these "Division Rules & Regulations" and the applicable "Section Rules & Regulations".

Pre-entry is required. **YOU MUST USE THE INTERNET ENTRY SYSTEMS FOUND AT [www.marylandstatefair.com](http://www.marylandstatefair.com)** Internet entries are due **July 31st**. Exhibitors without internet access should contact their County Extension Educator for assistance. All release forms are to be completed via the online entry system at time of registration. **After online entry, you will receive via mail an exhibitor letter and an attachment (show entry form) with instructions that must be returned to the Superintendent prior to the show.** Reminder you must have completed your Quality Assurance to be able to exhibit your animals. Check with your county to make sure you are up to date with this requirement.

**Entries for the 4-H Rabbit Show will be received in the Corner Show Ring (across from birthing center) – Cow Palace beginning at 8:00 am on Saturday, August 26, 2017. The 4-H Rabbit Show will begin at 10:00 am with Meat Pens judged first. This will be a carrier show with animals being released at the end of the show or as allowed by the Superintendent. .**

All rabbit exhibitors must fill out a [Self Certification of Rabbit Health](#) prior to loading animals at home and shall be presented upon request to the designated fair and show representative upon arrival at the show. The required form may be found on the Maryland Department of Agriculture website at <http://www.mda.state.md.us/animalHealth/Pages/Fairs-Shows.aspx>.

- a. Ear number substitutions will be allowed in same breed, variety, age and sex on the day of the show. No substitutions will be allowed for a different breed. **Rabbits must be permanently tattooed in left ear.**
  - b. All exhibits must be a breed recognized by ARBA. Mixed breeds are not allowed. The book, "Standard of Perfection" outlines the standards for each recognized breed. It can be ordered online at [www.arba.net](http://www.arba.net) or by calling (309) 664-7500. Exhibitors are responsible for obtaining a Rabbit Breeds and Varieties List from their 4-H Extension Educator to assist in properly filling out the entry form.
  - c. Exhibitors are limited to a total of **6** entries in the breed classes and 1 entry in the market pen class (3 rabbits/pen).
  - d. Any exhibit displaying signs of disease or in poor fleshing condition will be refused entry. The decision of the Superintendent is final.
  - e. With the exception of meat pens, rabbits under 3 months old or over 2 weeks pregnant will not be allowed. Meat pens should be at least 8 weeks old and not over 10 weeks of age.
2. **Ownership:** All rabbits must be the bona fide property of the exhibitor by June 1<sup>st</sup> of the current year.
  3. **Judging:** This is an official American Rabbit Breeders Association (ARBA) sanctioned show.
  4. Only rabbits entered in the show may be brought onto the fairgrounds. **The selling of rabbits on the fairgrounds is NOT PERMITTED.**
  5. Spectators, including family members/friends of Exhibitor, will only be allowed to observe the judging table from a reasonable distance as determined by the Superintendent. No one will be allowed in the cage area during judging except carriers and Exhibitors.

  7. The Grand Champion Market Rabbit must be sold through the Livestock Sale. Exhibitors of the Reserve Champion may sell their animal if they choose. Exhibitors are limited to a maximum of two species in the Livestock Sale. **Refer to State Fair 4-H/FFA Livestock Sale rules for additional information.**

### BREEDS (Sections 1-50)

#### Section Rules & Regulations:

1. The Market Pen consists of 3 rabbits that are all the same breed & variety, mixed breeds are not allowed. Age restriction: not over 69 days old. Weight restriction: each rabbit must weigh a minimum of 3lbs and cannot weigh more than 5lbs. All breeds will compete together.
2. The Champion and Reserve Champion Market Pens will be eligible to be sold in the Livestock Sale. Refer to State Fair 4-H/FFA Livestock Sale Rules.
3. **Awards:** Premiums and ribbons will be awarded to the 1st – 20th Place exhibits in each breed. Rosettes will be awarded for Best of Breed in all breed classes.

## SHOWMANSHIP (Section 51)

### Section Rules & Regulations:

1. **Pre-entry is required. See above for entry details.** Exhibitors will compete according to their 4-H Age (age as of 1/1/17) except for those entering in the Novice class (1<sup>st</sup> project year participating in Showmanship). Superintendent may at their discretion split classes.
2. Rabbit used must be entered in the State 4-H Rabbit show and be owned by the Exhibitor competing in this section.
3. There will be a 15-minute limit on presentations. Exhibitor's knowledge may be tested by answering questions related to the breed exhibited, diseases and standard management practices.

## EDUCATIONAL EXHIBITS (Section 52)

### Section Rules & Regulations:

1. 4-H'ers are invited to plan an educational exhibit to be on display during the State Fair in the 4-H/Home Arts Building. 4-H'ers will bring their exhibits to the Corner Show Ring in the Cow Palace on Saturday, August 26, 2017 from 8am to 9am . Following the show the exhibits will be moved to the 4-H/Home Arts Building where they will be displayed for the remainder of the fair. Exhibits can be picked up from 8pm to 10pm on Monday, September 4<sup>th</sup> or from 9am to 7pm on Tuesday, September 5<sup>th</sup>. The exhibit may be an informational poster or other educational display. Youth and adults working together are encouraged. Contact the Superintendent for more info. Each Exhibitor may enter 2 exhibits.
2. 4-H Members carrying a Rabbit project in the current year are eligible to participate. A \$5 Participation Premium will be paid. Remember– Cavy Educational Exhibits are offered in Department J, class 100.
