The grooming and preparation of all animals for exhibit is the responsibility of the Exhibitor. Exhibitors may receive guidance only from immediate family members, Maryland 4-H/FFA Members and appointed UME Volunteers/FFA Advisors.

### Division Rules & Regulations:

1. Exhibitors and their exhibits must comply with the "General State Fair Rules & Regulations", "General 4-H and FFA Rules & Regulations", "Animal Rules & Regulations", the "Maryland 4-H Code of Animal Science Ethics", the "Health Regulations for Livestock Exhibited in Maryland", these "Division Rules & Regulations" and the applicable "Section Rules & Regulations".
2. **Schedule for 2019:**
  - a. Beef exhibits received Wednesday, August 21<sup>st</sup>, 2:00pm – 8:00pm
  - b. Beef exhibits received Thursday, August 22<sup>nd</sup>, 7:00am – 9:00pm
  - c. Beef exhibits must be in place by 8:00am, Friday, August 23<sup>rd</sup>
  - d. Beef Heifer Check-In – throughout the day Thursday, August 22<sup>nd</sup>, and Friday, August 23<sup>rd</sup>, 8:00am to 11:30am  
All heifers (except Commercial) must be checked in with beef superintendents by 11:30am Friday, August 23<sup>rd</sup>
  - e. Beef Exhibitor Orientation – 12:00noon, Friday, August 23<sup>rd</sup>
  - f. Beef Steers, Commercial Heifers and Dairy Steers weigh 12:30pm, Friday, August 23<sup>rd</sup>
  - g. Steer Grading for Livestock Sale – at weigh-in – 12:30pm, Friday, August 23<sup>rd</sup>
  - h. Beef Heifer Show – 6:00pm, Friday, August 23<sup>rd</sup>
  - i. Beef Showmanship – 11:30am, Saturday, August 24<sup>th</sup>
  - j. Beef Steer Show – 6:00pm, Saturday, August 24<sup>th</sup>
  - k. 4-H/FFA All-Star Showmanship – 7:00pm, Sunday, August 25<sup>th</sup>
  - l. 4-H/FFA Beef Released (except for Livestock Sale Steers) - 8:00pm, Sunday, August 25<sup>th</sup>
  - m. Youth Livestock Auction – 7:00pm, Monday, August 26<sup>th</sup>

Pre-entry is required. **YOU MUST USE THE INTERNET ENTRY SYSTEMS FOUND AT [www.marylandstatefair.com](http://www.marylandstatefair.com) Internet entries are due July 31<sup>st</sup>.** Exhibitors without internet access should contact their County Extension Educator for assistance. All release forms are to be completed online through the entry system at time of registration. Reminder you must have completed the Animal Husbandry & Quality Assurance program to be able to exhibit your animals. Check with your county to make sure you are up to date with this requirement.

3. **Entries:** Entries will be received on Wednesday, August 21<sup>st</sup>, from 2:00pm to 8:00pm; Thursday, August 22<sup>nd</sup>, from 7:00am to 9:00pm; and Friday, August 23<sup>rd</sup>, from 7:00am to 8:00 am in the Cow Palace. **All beef animals must be in place no later than 8:00am on Friday, August 23<sup>rd</sup>.** Refer to "Schedule of Events" and "4-H/FFA Exhibit Entry Information" for additional information. **DO NOT BRING TACK/DECOR BEFORE Tuesday, August 20<sup>th</sup>. DO NOT BRING ANIMALS BEFORE WEDNESDAY, AUGUST 21<sup>ST</sup>! Tie-outs will be available in 2019.**
  - a. Only steers with purebred bloodlines can show in Angus, Hereford, and Shorthorn steer classes. **Breed Association registration papers are required at weigh-in and steers must be tattooed prior to arrival on fairgrounds.** All others must show as beef crossbreds.
  - b. Steers will be shown by breed and weight. **Indicate breed on entry form.** Steers must weigh a minimum of 1,000 lbs. All animals will be weighed and divided into classes at the superintendent's discretion. Number of classes may vary among breeds. **Re-weighing will NOT be permitted. Steers must be born on or after January 1, 2018.**
  - c. For heifers, indicate breed, date of birth, registration number, sire, and dam on entry form. Commercial heifers will be shown by weight, not by age.
  - d. Exhibitors are limited to not more than 5 steers, and may not win more than 2 premiums in any one class. **Exhibitors may enter up to 2 heifers per class per breed including Commercial heifers.**
  - e. **Steers and commercial heifers will be weighed beginning at 12:30pm, Friday, August 23<sup>rd</sup>** on the scales in the Swine Barn. **Market beef steers and the market dairy steers will be graded at the time of weigh-in at 12:30pm, Friday, August 23<sup>rd</sup>.** Exhibitor Orientation will be held on Friday, August 23<sup>rd</sup> at 12:00 noon in the Cow Palace Show Ring. Commercial heifer tags will be checked when heifers are weighed in at the Swine Barn scale.
  - f. Market steers must have a minimum average daily gain of 2.0 lb. to be eligible to show and sell at the Maryland State Fair in 2019. Starting weight and date must be verified by the County 4-H Extension Educator/ FFA Advisor. Refer to State Fair 4-H/FFA Livestock Sale rules for additional information pertaining to beef steer sale animals.
  - g. The Grand Champion Beef Market Steer MUST sell in the 4-H/FFA Livestock Sale on Monday, August 26<sup>th</sup>. Reserve Grand Champion Steer may sell (but is NOT required to sell) in the 4-H/FFA Livestock Sale. A total of **14 beef steers** (including the Grand Champion Beef Steer) will be sold in the Livestock Sale. **The market beef steers and the market dairy steers will be graded at the time of weigh-in on Friday, August 23<sup>rd</sup> at 12:30pm.** Refer to State Fair 4-H/FFA Livestock Sale rules for additional information pertaining to beef steer sale animals.
  - h. Steers and heifers must be dehorned and healed. Steers are to be castrated and healed except in class B21. For safety reasons, entries for animals not meeting these criteria will not be accepted.
  - i. Commercial heifers are unrecorded crossbreds. All current rules apply. These heifers will be shown by weight and divided into weight classes. **COMMERCIAL HEIFERS MUST BE TAGGED WITH AN OFFICIAL MARYLAND 4-H TAG BY JULY 1, 2019 and exhibitors must have a copy of their 4-H livestock registration form at check-in.**
  - j. Substitutions: Exhibitors may substitute one animal for another.
4. **Ownership:**
  - a. All steers must be the bona fide property of the exhibitor by January 1 of the current year. All steers must be tagged with a MD 4-H or MD FFA Livestock tag.
  - b. Breeding heifers must be the bona fide property of the exhibitor and must be **solely owned and registered in the name of the exhibitor only** by July 1, 2019. Cows and calves in the cow/calf class must be registered in the name of the owner and both must be tattooed. Registration certificates and tattoos will be checked by the superintendent. Entries received with "Papers Pending" will not be accepted. Cows entered in the Cow/calf class will not compete for Champion Female.

- c. Ear tattoos must be legible and conform to the respective BREED ASSOCIATION REGISTRATION CERTIFICATE. Exhibitors must clean the animal's ears (free of wax and/or dirt) prior to check-in of registered heifers and purebred registered steers.
- d. **Bred and Owned Classes: Exhibitors in the Bred and Owned Classes in 4-H/FFA animal divisions must be the breeder and the first and continuous owner of the animal entered. "Breeder" is defined as the recorded owner of the dam at the time of breeding/service. "First Owner" is defined as the recorded owner of the dam at the time the animal was born.**
5. Proper attire must be worn during the showmanship classes, steer show, heifer show, and the livestock sale. Refer to the 4-H AND FFA ANIMAL SHOW ATTIRE section under the GENERAL STATE FAIR RULES & REGULATIONS for show attire requirements.
6. **County Groups** - A county group shall consist of 4 animals (4 steers or 4 heifers) owned by four different 4-H and/or FFA members. Each county is limited to 2 entries. Exhibitors may only show in one county group.
7. Exhibitor Orientation will be held on Friday, August 23<sup>rd</sup> at 12:00 noon in the Cow Palace Show Ring.
8. All animals that compete in market or breed classes MUST compete in the breed and overall champion drives. Failure to compete will eliminate the exhibitor from Maryland State Fair 4-H competition the following year and will result in the forfeiture of all premiums in the current year.
9. Exhibitors must show their own animal. Refer to the "Animal Rules & Regulations" section of the GENERAL STATE FAIR RULES & REGULATIONS for more information and details.
10. **ALL 4-H BEEF DEPARTMENT SHOWS (SHOWMANSHIP, STEERS, & HEIFERS) WILL BE UNFITTED. This means animals can only be washed and blown out with NO adhesives, show foam, coloring agents, paints, oils or other fitting aids allowed to prepare cattle for show. Exhibitors ARE allowed to use hair and skin care products and conditioners (such as Revive, Kleen Sheen) as part of the regular daily grooming and hair maintenance of their beef cattle while at State Fair. Animals may be subject to being wiped with a white towel, cloth, etc. as they report to the make-up area and show ring.**

## BEEF SHOWMANSHIP

### Section Rules & Regulations:

1. Pre-entry is required. Internet Entry Forms are due to the State Fair by July 31, 2019. Exhibitors will compete according to their 4-H Age (age as of 1/1/19). Classes may be further divided at the sole discretion of the Superintendent. An Exhibitor is limited to showing one (1) animal (either a steer or a heifer). Animals must be owned by the exhibitor and entered in a breeding or steer class in this division. Refer to "4-H and FFA Fitting & Showmanship Regulations" for additional information.
2. Participants in Showmanship will be judged strictly on their showmanship in the ring. Judging Criteria: Performance in the Show Ring (60), Knowledge (30), and Personal Appearance (10). Showmanship animals **will not be fitted** and may only be washed, clipped and blown out prior to entry in the ring. No fitting products (oil, show foams, adhesives, coloring agents, paints, etc.) are to be used on the animal. Judge may ask questions of the contestants during this class.
3. Showmanship Grand Champion will be eligible to participate in the 4-H/FFA All-Star Showmanship Contest on Sunday, August 25, 2019 @7pm. See Division X, Section XV- 4-H/FFA All-Star Showmanship Contest for rules.

**\*\*NOTE:** If fewer than 12 animals and a minimum of 5 exhibitors have entered in a given breed, that breed may be shown in the AOB/Other Registered Purebreds division, at the discretion of the Superintendent.

## MARKET STEERS

Breeds: Angus, Hereford, Shorthorn, & Crossbred & Other Beef Breeds Steers. **Show order: Angus, Hereford, Shorthorn, Crossbreds & Other Breeds.** Market steers must weigh a minimum of 1,000 pounds and must have a minimum average daily gain of 2.0 lbs. to show. **An animal that does not make rate of gain remains eligible to be shown in Showmanship classes and market exhibition classes only. See General Rules & Regulations- Animal section rule #10 for details.** Refer to State Fair 4-H/FFA Livestock Sale rules for weight restrictions on sale animals.
