The General Rules and the Special Rules apply to this department plus the following:

- Show is open to mules and the following draft horse breeds: Belgian, Clydesdale, Percheron, and Other Breeds
- Recommended Dress Code for Hitch classes:
MEN - Drivers should wear dress slacks, coat and tie. Dress hats or tams and proper shoes are recommended.
LADIES - Drivers should wear dress, long skirt and blouse or dress pants. Clydesdale and Shire exhibitors should wear hat or tam.
ASSISTANT DRIVERS - Assistant drivers who enter the ring should also comply with the above recommendation.
- All exhibitors showing in Under Saddle must wear protective headgear (English and Western).
- Hitch classes will be judged: 60% on Manners and Performance; 20% on Conformation and 20% on Appointments.
- Youth exhibitors are only eligible to show in their respective youth classes.
- Youth age as of January 1st of the current year.
- All entries must be received by July 30, 2021. Use entry form enclosed with the Prize List.
- Post entries will not be accepted.
- Stallions are not permitted in Youth Driving Classes.

Class Specs:

- Walk-Trot - To be shown both ways of the ring at a walk and trot. To be judged on manners and performance. Not to back. *Horse/rider combination may not show in U/Saddle classes.*
- Under Saddle - To be shown both ways of the ring at a walk, trot and canter. To be judged on manners and performance. Not to back. *Horse/Rider combination may not show in Walk-Trot classes.*
- Junior Decorator - Youth must roll a mane and tie a tail in 30 minutes. Will be judged on neatness and tightness of mane roll and tail, appropriateness of decorations and overall appearance of horse.
- Mulemanship/Horsemanship - Judged on guidance and control of mount over a special pattern which will
