GENERAL RULES

1. Entry times for the Home Arts Sections are as follows:

SECTIONS A, B, C, D, E, F, G, H, K, L, N
(Use Land Street Entrance-Rear of Building)
Sunday, August 21st, 2PM – 8PM
Monday, August 22nd, 9AM – 7PM

SECTION M
First Baking Show (Use Land Street Entrance)
Sunday, August 21st, 2PM – 8PM
Monday, August 22nd, 9AM – 7PM
Second Baking Show (Use Land Street Entrance)
Wednesday, August 31st, 3PM – 8PM
Third Baking Show (Use Land Street Entrance)
Wednesday, September 7th, 3PM – 8PM

2. No admission passes will be furnished. Exhibitors are admitted without charge during entry times for each section. Others must pay the regular admission.
3. Entries in all sections must be the work of the exhibitor and entered in his/her name. **Only 1 entry per class is accepted from any one exhibitor.**
4. No entry will be accepted unless there is a specific class for it in the premium list.
5. All entries must be fresh, clean and conform to size or content specifications.
6. All entries must have been completed since August 2021, except as noted.
7. Home Arts entries **RELEASED** Monday, September 12th, 9AM - 7PM. Unclaimed exhibits become the property of the Maryland State Fair by September 30th.
8. All prize money and ribbons must be picked up with exhibit when released. Decisions of the judges are final. At their discretion the judges may open and examine any entry and refuse to consider any entry for a prize.
9. Only residents of Maryland and adjoining states are eligible to enter.
10. A Fair President and an Anna Troyer ribbon will be awarded in each section. Honorable Mention ribbons do not receive prize money, but are awarded when the judges feel that an entry deserves special notice.
11. 2021 Special Award winners will not be eligible to receive a Special Award this year, 2022.
12. **For your convenience, you should pre-enter by mail or Internet, although walk-ins will be accepted.**
13. **Unless otherwise noted professionals are excluded from submitting entries. A professional is defined as one who has earned a certificate/degree, or is currently employed in related entry category field. An amateur is one who creates for pleasure.**
