The General Rules and the Special Rules apply to this department plus the following:

**Fitting and Showing Section** - Open to children 17 years of age and under as of December 1, 2021. To be judged on the child's ability and knowledge of cleaning and grooming procedures, as well as showmanship. Age to be taken into consideration. Classes are shown individually starting with class F701. No foals allowed. Only one child to a horse/pony. All children and ponies/horses will enter the ring at the same time and **adults or helpers may accompany them into the ring to carry their grooming equipment but must leave before the judging begins.**

If a child needs assistance in the ring during the contest, the Ringmaster will assist. The ponies/ horses will be tied to the fence. The children must have their own grooming equipment with them and no ponies/horses may enter the ring braided. Children should be clean, tidy and dress to groom, not to ride.

- Negative Coggins Certificate
- Biosecurity Self Certification Form
